<b>MAIN CHALLENGE OF THE 2022 PRE-FORUM</b>	Address the topic of the new sustainability regulation from the food safety angle and multi-actor perspectives, by actively involving EC agencies, researchers, food safety authorities, consumers' representatives, industries and all the stakeholders of the value chain.
