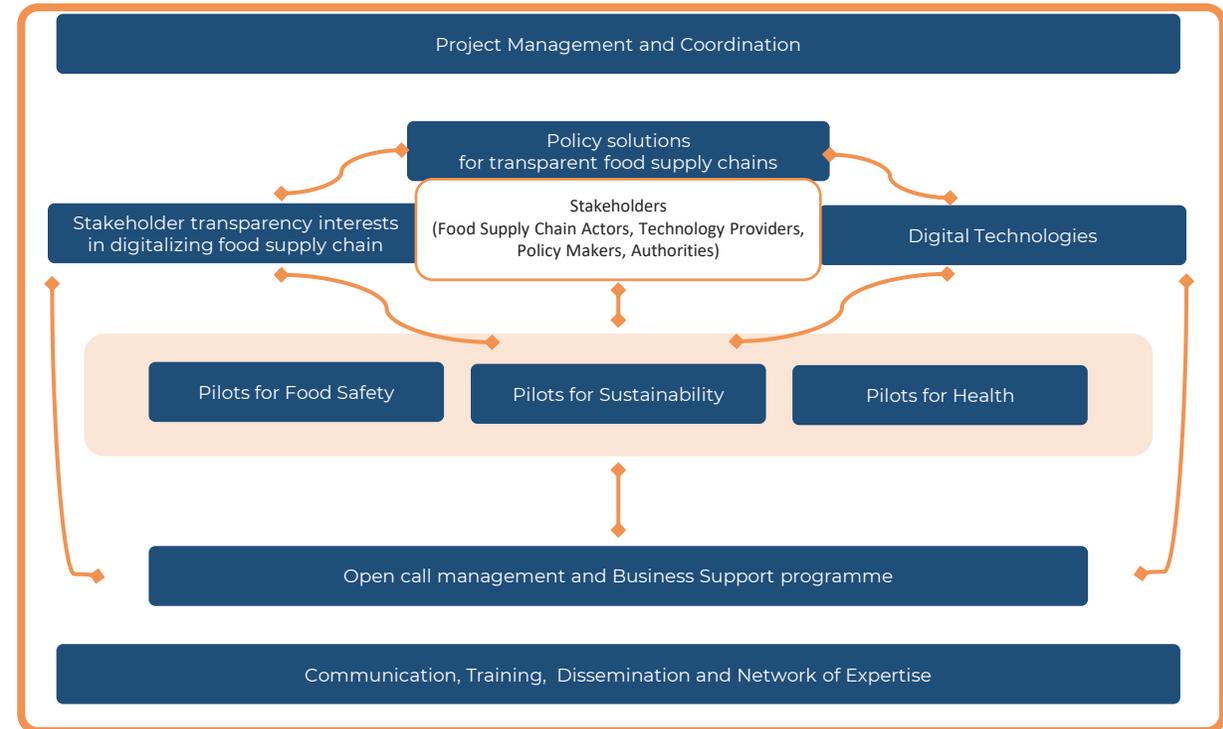


TITAN Relevant outputs

Differed views among stakeholders on what and how to inform consumers

Only 12% considers sustainability information reliable
