European Commission reports on public consultation about FCM revision

The European Commission published the final report on the [consultation](#) for the revision of EU rules on food contact materials, titled "[Public consultation on the revision of EU rules on food contact materials \(FCMs\)](#)" that took place from October 5, 2022 to January 11, 2023.

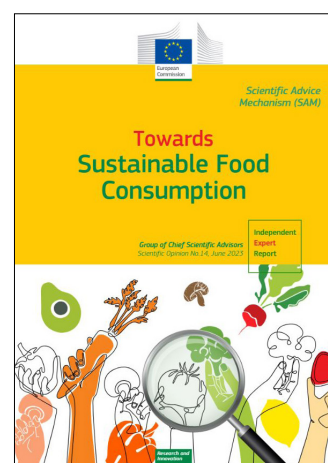
The report summarizes the outcome of the consultation period and gives insights into categories and countries of origin of participants. A total of 610 feedback instances were received spread over 31 different countries.

This initiative aims to modernise the rules, to ensure food safety & a high level of public health protection, to reduce the presence and use of hazardous chemicals, to take account of the latest science & technology, to support innovation & sustainability by promoting safe reusable and recyclable solutions, and help reduce the sector's environmental impact.

New review report and policy recommendations on sustainable consumption

The 28th of June, the EU Scientific Advice Mechanism (SAM) released its evidence review report and policy recommendations on sustainable food consumption. The work aims to support the preparation of the legislative framework for sustainable food systems EN and complement the Farm to Fork Strategy EN.

The SAM was asked to provide scientific advice on how to overcome the existing hurdles in the food system, such as the difficulties customers face when picking environmentally friendly items, the general lack of convenient sustainable alternatives or lack of information about a product's sustainability. These barriers lead people into unsustainable consumption patterns and contribute to environmental deterioration while worsening social disparities.

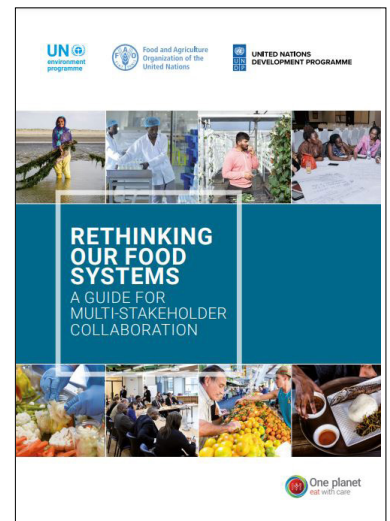

Rethinking our Food System - A Guide for Multistakeholder Collaboration

The United Nations agencies, FAO, UNEP and UNDP have combined efforts and knowledge to develop and co-launch a guide to help stakeholders to rethink food systems through multi-stakeholder collaboration. The guide entitled “Rethinking Food Systems: A guide for Multistakeholder Collaboration” is designed to support national and international multi-stakeholder initiatives, and to contribute to the follow-up to the 2021 UN Food Systems Summit. It was developed for individuals, teams and organizations charged with convening and facilitating multi-stakeholder initiatives of all scales and types related to sustainable food systems transformation.

Mapping ERC frontier research sustainable food production and consumption

The ERC - European Research Council Executive Agency, European Commission, has published the report highlighting ERC projects funded under the H2020 Framework Programme for Research (2014–2020) and a selection of FP7 projects (funded between 2007-2013) that provide new knowledge, new perspectives or innovative solutions to the areas identified under the ten pathways in the EU’s Food 2030 research and innovation policy.

The ERC funded projects are in various ways relevant for these pathways, either through the advancement of our understanding of the underlying causes of the sustainability challenges at hand and/or by proposing concrete solutions for overcoming these.

The report includes also the last frontier bottom-up research relevant for the food safety systems.

Food 2030 provides the policy framework to accelerate this transition within safe planetary boundaries, in line with, and supports, the goals of the European Green Deal, Farm to Fork strategy and bioeconomy strategy.
