Brussels, December 21, 2023 – The first European Food Safety Forum, held on November 28 and 29, 2023 in Brussels, concluded with resounding success, gathering over 120 participants from across Europe. Food Safety stakeholders from science, policy and society convened to share ideas, create synergies, and shape the future of the European food safety system together.



As the final flagship event of the FoodSafety4EU project funded by the European Commission, the Forum showcased the diversity and strength of the food safety community in Europe, bringing together experts from various disciplines to collaborate on innovative approaches and solutions. Notable highlights include the creation of potential synergies between EU-funded projects, with participants actively engaging in discussions and sharing groundbreaking ideas.

A particularly inspiring aspect of the Forum was the contribution of young scientists who shared their innovative ideas, injecting fresh perspectives into the EU dialogue. This emphasis on inclusivity and the exchange of ideas reflects the commitment of the European Food Safety Forum to nurturing the next generation of leaders in the field.

The climax of the event was the signing of the Terms of Reference (ToR) for the EU Food Safety platform, launched earlier this year as one of the main outcomes of the FoodSafety4EU project. Representatives from key entities such as the European Commission DG Research & Innovation, the European Food Safety Authority (EFSA), the Research Executive Agency (REA), and the European Commission's Joint Research Centre (EC-JRC) were present for this significant moment. **21 project partners signed the agreement**, symbolizing a renewal of mutual trust and commitment to continue shaping the EU Food Safety System of the future. This collaborative effort underscores the importance of a united front in addressing the complex challenges of ensuring the safety of the food supply chain and its governance.

In conjunction with the success of the EU Food Safety Forum, we celebrate the conclusion of the FoodSafety4EU project, which has played a pivotal role in advancing food safety initiatives in Europe.

The impact of FS4EU extends beyond the project's conclusion, as it has laid the groundwork for ongoing collaboration and progress within the food safety community.
